It has come to the light that there is no Workload in several subjects in several Government Degree Colleges in the state. To arrive at the factual position, the Regional Joint Directors of Collegiate Educations in the State have been directed to verify the Workload and vacancy position of each of Government Degree Colleges in their respective Zones in consultation with the Principals of each of Government Degree Colleges and give status report.

The reports submitted by the Regional Joint Directors concerned revealed that in certain Government Degree Colleges the Lecturers are working more than required number with reference to workload resulting in surplus. Similarly, in certain Government Degree Colleges the number of Lecturers working are less than the required number with reference to workload resulting in shortfall.
